1 - YOUR CONDITIONS AS A STUDY PERMIT HOLDER IN CANADA

As a study permit holder, there are a number of conditions you need to meet. If you don't meet these conditions, you may lose your student status and study permit. You may also have to leave Canada.

A study permit holder is allowed to work off-campus **up to 24 hours** a week when enrolled in a **full time program**. If the **program is part-time**, you are not allowed to work off-campus. A co-op work permit is also required for programs with work experience component such as practicum, clinical placement, co-operative placement. Study Permit holders are not permitted to attend online-only programs.

If your co-op work permit application is delayed due to IRCC processing times, you may complete your work experience component with the allowed 24 hours a week as a study permit holder until a decision is made on your application. It is prohibited to participate in any type of work (paid or unpaid) longer than 24 hours a week which includes your practicum or co-op placement.
